**ELIGIBLE OWNERS AND LESSEES MAY SUBMIT A CLAIM FOR BENEFITS BEGINNING ON MAY 25, 2020**

**If your vehicle previously suffered a failure of its timing chain system within 10 years or 160,000 kilometres, whichever comes first, you may claim:**

- **Repair and/or replacement of the timing chain system – OR –**
- **Engine repair or replacement** caused by a failure of the timing chain system

**If your vehicle suffers a failure of its timing chain system after May 25, 2020, you may claim:**

- **Repair and/or replacement under warranty** by taking your vehicle to an authorized dealership

**HOW DO I MAKE A CLAIM?**

- The period for submitting a claim begins on May 25, 2020 and runs until January 25, 2021.
- You may complete a paper claim form available at [www.timingchainsettlement.ca](http://www.timingchainsettlement.ca) and submit your form by mail, courier or email to the addresses indicated on the form.
